## DECLARATION OF PURSUANT TO 28 U.S.C. § 1746 UNDER THE PENALTY OF PERJURY

1.	I am over the age of 18 and make this Declaration based on personal knowledge.	
2.	I worked with Ms. and Mr. Luis Anzola at the Coach House flagship	
	location in New York City (Coach) from February of 2023 until September of 2023.	
3.	I was hired as a sales associate in November of 2022.	
4.	Ms. was the Store Manager of Coach during my employment.	
5.	Ms. was my direct supervisor.	
6.	During my time at Coach, Mr. Anzola made inappropriate comments to and invaded	
	the personal space of Ms. several times per week.	
7.	Mr. Anzola frequently made comments referring to Ms. physical appearance and relationship status.	
8.	Mr. Anzola regularly left his own workstation in order to stare at and stand directly	
	behind Ms. while she worked, invading her personal space.	
9.	Prior to March 2023, my coworker, informed me that Luis was "handsy."	
10	In March of 2024, Ms. reported Mr. Anzola's behavior to	
11	Following Ms. complaint, conducted an internal	
	investigation by observing Mr. Anzola on the sales floor and speaking to myself and some of my coworkers.	
12.	informed me that because Luis had been with Coach for a long time,	
	she would not be able to "do much" to discipline him.	
13.	informed me that she issued a verbal warning to Luis.	
14.	Mr. Anzola often behaved flirtatiously with female customers. He asked customers	
	whether they were married, told them that they were beautiful, and stood so close to	
	them that customers took a step back, away from Mr. Anzola.	
15.	During my time at Coach, I experienced inappropriate sexual advances from a fellow	
	sales associate, frequently made sexual innuendos, jokes, and	
	comments about my body. He showed me explicit sexual content on his phone, and	

once in a "Boudoir" magazine which he hande	d out to myself and my coworkers. It
contained photos of naked men.	
16. I reported the sexual harassment to	, at which time she conducted an
internal investigation.	e to report any more instances of
harassment to her.	
17. The harassment continued after my first report	; I reported two additional instances of
sexual harassment from to	Each time told me
to report to her if it happened again.	
18. After I reported the sexual harassment, the man	nagement at Coach often accused me of
not being a good team member and of stealing	sales from coworkers. Prior to my
complaint, I had never received any such feedb	back.
19. I resigned from my position as Sales Associate	in September of 2023.
20. During my exit interview with	informed that I was resigning
because I felt disconnected from my coworkers	s and from Coach's management due to
the change in attitude after I reported my exper	rience of sexual harassment.
